In recent months, a few members were suddenly unsubscribed from the listserv because their email program automatically marked an Intellenet-L listserv message as spam without their knowledge. When an email address is unsubscribes from the listserv, the listserv system automatically and immediately stops sending mail to that list member. If you suddenly stop receiving Intellenet-L listserv messages, please double check your email program including your spam/junk folder to see if you've received a notification that your email account has been unsubscribed from the group.

Thankfully, groups io has a process in place to easily resubscribe. Whenever an email is unsubscribed from the group, an email message is automatically sent to the affected email address notifying the list member that they have been unsubscribed and provides instructions on how to resubscribe.



New Member Profile Joseph Lawless



Joseph Lawless is the Senior Transportation Security Specialist for The Edward Davis (former Boston Police Commissioner) Company. Lawless was formerly the chief law enforcement & security officer for Mass-Port's maritime properties located in South Boston, East Boston & Charlestown. While at MassPort, Lawless was in charge of development & implementation of policing, security & emergency planning strategies for all facilities including the Boston Fish Pier, Cruiseport Boston & Conley Container Terminal.

Lawless is recognized as a security industry leader, both locally & nationally. He is a member of the National Maritime Security Advisory Committee. The committee is comprised of 22 members representing all segments of the industry & provides advice to the Secretary of the Department of Homeland Security via the Commandant of the U.S. Coast Guard on matters such as national security strategy & policy, actions required to meet current & future security threats, international cooperation on security issues & security concerns of the maritime transportation industry.

Lawless served as the Chairman of the American Association of Port Authorities (AAPA) Security Advisory Committee, a position he has held since 2009. The AAPA is the principal voice of 160 public port authorities in the U.S., Canada, Latin America & the Caribbean. He has testified before Congress on key issues involving port security.

Lawless created & chairs the weekly Port Security Operations meeting, a public & private security collaborative, attended by representatives of over twenty different agencies & corporations. Lawless received the 2012 International Police 9/11 Medal for Extraordinary & Distinguished Lifetime Achievement in fighting terrorism & trans-national crime from the International Association of Airport & Seaport Police.

Lawless has 37 years of law enforcement& security experience, including more than 13 years with the Massachusetts State Police Uniform Patrol, Criminal Investigations & Executive Protection units. He went to Massport in 1993 overseeing all aspects of public safety. In this role he oversaw Logan Airport-based Troop F of the Massachusetts State Police. During this time, Troop F became the first law enforcement entity accredited by the International Association of Airport & Seaport Police for their commitment to excellence.

Lawless, a licensed private investigator in Massachusetts & Nevada is also Board-certified as a Homeland Security Specialist by the American College of Forensic Examiners & also serves on several national & international panels that focus on security. Lawless received his B.A. from Merrimack College located in Andover, Mass & an M.A. from Boston University.



Intellenet Scholarship Award

Established in 2017 and annually thereafter Intellenet plans to award at least two scholarships to a child, step child, grand child or grand step child of an Active Member in good standing of Intellenet. The scholarships are intended to provide financial assistance to students entering their first year of college, a post graduate year, vocational/trade school or students presently attending a college or university. A scholarship will be awarded to one child of an active Intellenet member's family. The recipient or recipients will be chosen by the Scholarship Committee, selected by the Intellenet Executive Director, and their decision will be final. Previous Intellenet scholarship award recipients are not eligible to apply. Only those who plan to be enrolled the ensuing fall semester are eligible to apply. It is the expectation of Intellenet that the applicant be in good standing with their present academic institution.

Criteria

All applicants must meet the following eligibility requirements: Be child, step child, grand child or grand step child of an Active Member in good standing of Intellenet, and one of the following: A high school senior who will be continuing their education at an undergraduate college or university, junior college, vocational or technical college. A high school senior who will be continuing their education in a post graduate year. A post-secondary student attending an undergraduate college or university, junior college, vocational or technical college.

Application Procedure

The application is on the following page and can be submitted electronically to the Scholarship Committee by emailing intellenet@intellenet.org. Applications must be submitted no later than February 22nd at 5:00 PM EST. The scholarship recipients will be announced at the yearly Intellenet Conference gala banquet. Recipients of the scholarship will be required to provide proof of enrollment at an eligible post-secondary institution prior to the funds being dispersed.
